

INFORMATION NOTICE RELATED TO PROCESSING OF DATA PROTECTION

The present notice provides detailed information related to the protection of your personal data in your capacity of visitors and users of the www.frigotehnica.ro web site of Frigotehnica S.R.L. with its headquarter in Bucharest, 24 Delea Veche Street, Building A, 11 floor, 2nd district, contact date of the data protection responsible is dataprotection@frigotehnica.ro (hereinafter called as "**Frigotehnica**" or "**We**")

Personal data represents any information related to an identified or identifiable natural persona; an identifiable natural person is a persona that may be directly or indirectly identified, in particular by reference to an identity element, such as name, an identity number, location data, online identifier, or to one or more specific elements, specific to its physical identity, physiological, genetic, psychic, economic, cultural or social.

Frigotehnica is responsible, in its capacity of processor, for processing your personal data during the development of our activity. By the present notice we inform in respect to your personal data that we use, the considered purpose, categories of recipients to which we transfer these data, storage duration and how you may exercise your rights granted by law in respect to personal data processing.

THE PURPOSE AND LEGAL GROUNDS FOR PROCESSING YOUR PERSONAL DATA

The purpose of collecting and processing your personal data is the communication between Frigotehnica and you in order to reply to the requests mentioned in the communication form or in the interest statement. Also, Frigotehnica collects data through the website in the moment you are visiting the site.

Frigotehnica collects, processes personal data only and exclusively for the purposes mentioned above and to the extent necessary to effectively achieve the above mentioned purposes. The data are suited, pertinent and non-excessive in relation with the purposes for which they are processed at a certain moment, exactly and, if necessary, updated.

Processed personal data:

- name, surname, address, phone, e-mail;
- information collected by cookies, as: IP address, used browser, information related to the software applications installed on your device.

STORAGE PERIOD

We will keep your personal data for a period necessary to achieve the objectives/purposes for which they were collected and processed. Subsequently, we will continue to process your data, in

compliance with the minimizing and limitation to the scope principle, in case we are under a legal obligation or we have a legal interest.

We will delete your personal data in the moment in which storage is not supported by any of the processing legal grounds.

PERSONAL DATA RECIPIENTS

There are certain situations in which we may disclose your personal data to third parties if we have a legal obligation in this respect or when we need to comply with contractual obligations.

Cookies

In order to ensure that the site is functioning properly, Frigotehnica places from time to time small files of data, called „cookies“ on your computer. Additional information related to cookies you may find on the Cookies Policy.

YOUR RIGHTS AND HOW YOU MAY EXERCISE THEM

In accordance with the provisions of (UE) 2016/ 679 Regulation you have the following rights:

- To access the data: you may obtain information related to the processing of your personal data and a copy of these data.
- To rectify the data: in case you consider that your personal data are inaccurate or incomplete, you may request an appropriate change of these personal data.
- To obtain the deletion of data: you may request the deletion of your personal data, to the extent provided by law.
- To restrict the processing: you may request to restrict the processing of your personal data.
- To object to processing: you may challenge the processing of your personal data, for reasons related to your particular situation.
- To data portability: you have the right to request that your personal data which you provided us to be returned or if possible transferred to a third party.

Processing your personal data for the purposes mentioned above will not involve the existence of an automatic decisional process.

You may exercise your above mentioned rights sending a written request, dated and signed to email dataprotection@frigotehnica.ro or by post to address 24 Delea Veche Street, Building A, 11 floor, 2nd district, Bucharest.

In addition to the above, you have the right to submit a complaint to the National Supervisory Authority for Personal Data Processing (ANSPDCP), Avenue G-ral. Gheorghe Magheru 28-30, 1st
